

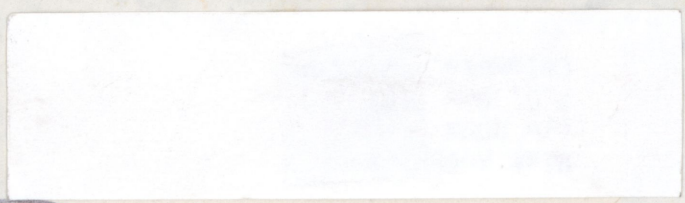

3. GCFDA Quarterly Meeting -- Officer Nominations!

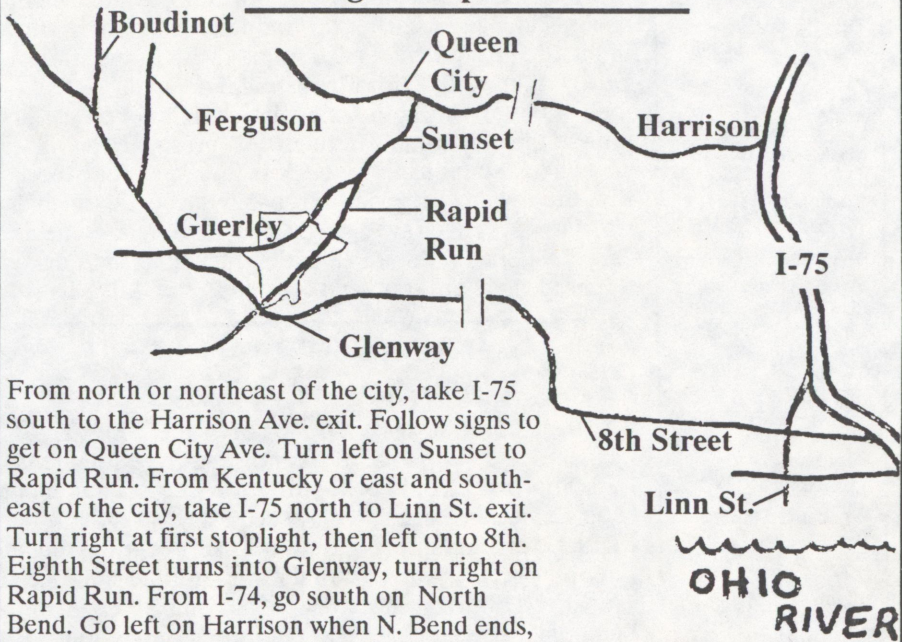

Getting to Rapid Run Park:



From north or northeast of the city, take I-75 south to the Harrison Ave. exit. Follow signs to get on Queen City Ave. Turn left on Sunset to Rapid Run. From Kentucky or east and south-east of the city, take I-75 north to Linn St. exit. Turn right at first stoplight, then left onto 8th. Eighth Street turns into Glenway, turn right on Rapid Run. From I-74, go south on North Bend. Go left on Harrison when N. Bend ends, then right on Boudinot, left on Glenway.
